A meeting of the La Grange Park Youth Commission was called to order at 7:00 p.m. on Monday, March 9, 2020 at the La Grange Park Village Hall.

**1. Call to Order**

Assistant Village Manager Emily Rodman called the meeting to order at 7:08 p.m.

**5. Village Board Meeting Sign Up**

Assistant Village Manager Emily Rodman encouraged a member of the Youth Commission to attend the upcoming Village Board Work Session meeting that was being held on March 10, 2020. Ryan McAllister volunteered to attend the meeting.

**6. Approval of Minutes - February 10, 2020**

*There was a motion to approve the minutes of February 10, 2020 by William Aikens. The motion was seconded by Ryan McAllister and passed unanimously by voice vote.*

**7. Review of Village Board Work Session Meeting of March 10, 2020**

Julia Reven volunteered to chair the meeting. Ms. Reven reviewed the Village Board Agenda Memo regarding the Renewal of Paramedic/Firefighter Agreement. At the conclusion of the discussion, there was a *Consensus to Approve a Motion: To Approve a Resolution Approving Proposal For Paramedic /Firefighter Services for 2020 Through 2023 As Submitted By Paramedic Services of Illinois, Inc. (PSI)*

Ms. Reven reviewed the Village Board Agenda Memo regarding the 2020 Sewer Cleaning and Televising. At the conclusion of the discussion, there was a *Consensus to Approve a Motion: (1) To Accept the Bid Proposal from Sewertech, LLC, for \$28,898.00 and (2) To Authorize the Village Manager to Execute the Contract Documents.*

Ms. Reven reviewed the Village Board Agenda Memo regarding the FY20/21 Inflow and Infiltration Control Program – Edwin Hancock Engineering Agreement. At the conclusion of the discussion, there was a *Consensus to Approve a Motion: To Approve and Authorize the Village Manager to Execute Agreements Between the Village of La Grange Park and Edwin Hancock Engineering for Engineering Services in an Amount Not to Exceed \$16,000 for Infiltration and Inflow Control Program.*

Ms. Reven reviewed the Village Board Agenda Memo regarding the 2020 Spring Tree Planting Program – Purchase of Parkway Trees from St. Aubin Nursery. At the conclusion of the discussion, there was a *Consensus to Approve a Motion: To Approve and Authorize the Purchase and Planting of Parkway Trees in a “Not to Exceed” Amount of \$13,000.00 from St. Aubin Nursery and Landscape.*

Ms. Reven reviewed the Village Board Agenda Memo regarding the 2020 Sewer Lining Project. At the conclusion of the discussion, there was a *Consensus to Approve a Motion: (1) To Accept the Bid Proposal from Insituform Technologies USA, LLC for \$139,136.00 and (2) To Authorize the Village President to Execute the Contract Documents*

Ms. Reven reviewed the Village Board Agenda Memo regarding the Water Main Replacement Program Update.

Ms. Reven reviewed the Village Board Agenda Memo regarding the Sidewalk Segment at 26<sup>th</sup> Street and Ostrander Avenue. The Commission discussed the issue at length and while the Commission remains opposed to the installation of a sidewalk between the Forest Preserve Groves, if installed, there was a consensus to install a gravel sidewalk.

## **8. Community Volunteer Day**

AVM Rodman expressed the importance of Commission members attending the Community Volunteer Day. She noted the date had been set for May 2, 2020.

## **9. Adjourn-next meeting April 13, 2020**

With no further business to come before the Commission, *there was a motion to adjourn. The motion to adjourn was made by Sophia Lazarski and was seconded by William Aikens and passed unanimously by voice vote.*
