Dena Ranieri of Jacobs Engineering was present to answer any questions, she mentioned the structural inspection. Ms. Ranieri mentioned the reasons for the upgrade due to changes in technology. Chief Maggos discussed Section 4 of the Zoning Code

and why this item came to the ZBA and how a building permit still needs to be obtained. At the end of discussion there was a *motion by Committee Member Domagalski to approve the site plan application of FMHC Corporation for the Verizon Wireless Antenna Facility at 937 Barnsdale. The motion was seconded by Committee Member Studwell. Motion carried on a voice vote.*
