2. Public Comment

There was no public comment.

Village Manager Julia Cedillo introduced herself and summarized the State of the Village Address. Discussion began over the State of the Village and questions were answered by Village Manager Cedillo for the Commission.

3. Introduction of New Members

4. Approval of Minutes- October 13, 2014

Ms. Hannah Husemann made a motion to approve the minutes from September 8, 2014. Mr. Fuentes seconded the motion. Motion to approve passed unanimously on a voice vote.

5. Review of Village Board Work Session Meeting of October 14, 2014 (Laura McAllister to review)

Ms. McAllister summarized the October 14th Village Work Session Meeting and how and why the Board voted on the items on the agenda.

Village Manager Cedillo and Fire Chief Dean Maggos updated the Commission on the item regarding Cook County Health Inspections.

6. Review of Village Board Work Session Meeting of November 11, 2014

Ms. Husemann began with the first item discussion & action-Adoption of the Cook County Multi-Jurisdictional Hazard Mitigation Plan-Volume 1 and the Village of La Grange Park's portion of Volume 2. Discussion began over Hazard Mitigation Planning for Cook County and for La Grange Park. Village Manager Cedillo and Fire Chief Maggos summarized the reasons for the planning as well as all the work by Village staff. Discussion moved to the grant funding for the Village Hall Complex Emergency Generator. At the end of discussion Ms. Husemann made a *motion to approve Resolution No. 14-24, which allows for the Adoption of the Cook County Multi-Jurisdictional Hazard Mitigation Plan-Volume 1 and the Village of La Grange Park's portion of Volume 2. The motion was seconded by Ms. Scotty and passed unanimously by roll call.*

Ms. Husemann moved on to the next item discussion-2014 Property Tax Levy. At the end of discussion there was consensus to approve the *motion to approve an Ordinance Providing for the Annual Tax Levy for the Village of La Grange Park, Cook County, Illinois, for Fiscal Year Beginning May 1, 2014 and Ending April 1, 2015. Motion to approve an Ordinance Providing for Specific Reductions of the 2014 Property Tax Levy Pursuant to the Property Tax Extension Limitation Law.*

7. Special Topics

Village Clerk Seidel and Village Manager Cedillo summarized the purpose and goals of the Youth Commission.
